On March 2, Palisades Post 283 will also be hosting the "Challenges and Opportunities" forum for Women Veterans. The free event aims to assist Women Veterans transition to civilian life, with professionals ready to answer questions about medical care, employment, and more. Prospective attendees are encouraged to RSVP promptly, as space is limited (see below). A recent GAO study suggests that Student Veterans are significantly more likely to seek mental health treatment than both non-Veteran students and Veterans over the age of 35, particularly since the COVID-19 era began. However, it's unclear whether this indicates an increased willingness to skirt stigmas surrounding mental health care or an increased need for mental health care among Student Veterans.

AMERICAN LEGION STANDS WITH GOLD STAR SPOUSES IN SUPPORT OF H.R. 3651 | Feb 14, 2024

The American Legion is urging members of the Legion Family to engage with their respective members of Congress, advocating for support of <u>H.R. 3651</u>, bipartisan legislation designed to ensure surviving spouses of military servicemembers maintain survivor benefits in the event of remarriage.

The Love Lives On Act aims to change the existing circumstances for Gold Star Spouses who choose to remarry before reaching the age of 55 risk losing essential benefits. The proposed bill extends to surviving spouses of activeduty, Veteran, and retired military personnel. Rep. Dean Phillips (D-MN) introduced the bipartisan bill along with Rep. Richard Hudson (R-NC). Senators Raphael Warnock (D-GA) and Jerry Moran (R-KS) are spearheading the Senate counterpart to the Love Lives On Act.

"Spouses of those who die in service to our nation make unimaginable sacrifices and deserve unending respect and support in return. The Love Lives On Act is part of my mission to ensure military families have access every single benefit they are owed," said Phillips, who lost his birth father in the Vietnam War. "I'm grateful to colleagues on both sides of the aisle for backing it, but our work is not done. I will continue to push to eliminate remarriage benefit reductions for anyone who dies in service to their country, civilian or military."

This legislation proposes several key measures:

- Removal of the age restriction for remarriage without loss of benefits.
- Permission for remarried surviving spouses to retain educational benefits.
- Safeguard Commissary and Exchange benefits for remarried spouses. Additionally, the act seeks to:
- Restorate TRICARE benefits for remarried spouses in case of subsequent marital dissolution.
- Eliminate the outdated "Hold Themselves Out to Be Married" clause, which unnecessarily instills fear and restricts freedom.

The American Legion asserts its commitment to championing the rights and entitlements of Gold Star Spouses, believing these individuals should not face repercussions for seeking love again. They ought to remain the surviving partners of fallen heroes, deserving of their benefits through their service and sacrifices.

The Legion Family is encouraged to reach out to members of Congress, urging their support for the Love Lives On Act. Check in with the VA! Checking in with the VA isn't always easy or a pleasant way to start the new year, but hear me out. The VA has many new programs that can support veterans and their families, and you or the veteran in your life may have changed over the last year. Simply visiting the VA website at www.va.gov/ and reviewing what's changed may help connect you with services you were unaware of. Also, VA Disability compensation rates have also increased for 2024. You can check the new rates out by visiting www.va.gov/disability/compensation-rates/veteran-rates/. Last but not least, if you have a service-connected disability, make an appointment with the VA to have it looked at. You could see a rating increase if your situation has changed since you last visit.

Volunteer! Last year we started a program to help some of our local veterans with everyday tasks that can be difficult for them do because of disability or other limitations. Some of these tasks included simple things like raking leaves, moving furniture, changing smoke detector batteries, and providing rides to doctor appointments. We are looking for volunteers to help with this assistance as our efforts grow.
